3. Neither I, nor my parent or immediate family, is employed by the 23rd District Agricultural Association (Contra Costa County Fair).

5. The selected participants will receive, waved entry fees (up to \$15), 1 on grounds parking pass, Community Service Credits for school (by request).

Should I be chosen to be a part of the 2013 Contra Costa County Fair Barn Crew Team, I will assume the responsibility of the position which includes:

1. Participating in the following dates:
 - April 2014 Application Process
 - May 2014 (TBA) Barn Crew Meeting
 - Pre tagging and official pre weight registration.
 - Pen Set up prior to fair
 - May 23-June 1 Jr. Livestock Market Show and CCC Fair
2. Performing the duties of a Barn Crew Team Member, I will attend team building meetings and work days prior to fair. During the week of fair I will help run livestock shows, the auction, and other events. I will be directly involved in the awards night planning. Throughout the week of fair I will be the face of the Jr. Livestock program, other exhibitors will look to me for help and I will be able to assist them in any way needed.
3. As a participant, I understand that the Fair time t-shirt, badges, and parking passes that are given to me are gifts from the Contra Costa County Fair and I will be held to the highest standards when using and wearing them.
4. I understand that the purpose of the Barn Crew is to positively represent the Jr. Livestock Program, the Contra Costa County Fair, and the Fair Board of Directors, and aid in improving the program for future participants. All contacts with the media and public will be made through the Livestock Coordinator.
5. While participating in any Fair related activities I will not consume drugs and/or alcohol or smoke cigarettes. I will follow the rules set by the Jr. Livestock Program and any other 4-H/Grange/ FFA organizations I am affiliated with.

In the event that I should break the terms of this agreement; if my conduct is in any way damaging to the Contra Costa County Fair; or if for any reason I should be unable to fulfill my duties as a Barn Crew Member, I will be asked to leave the program and will be suspended from participating in future Barn crew Programs for up to 2 years.
